County Engineer Angie Kersten reviewed a Contract for Park View ARPA Projects for three tied Portland Cement Concrete (PCC) road reconstruction projects. She also reviewed the advertising and bidding steps taken, the receiving of seven responsive bids, and the confidentiality of unit pricing as to why it was not included in the packet.
